

### Minister's Annual Report for 2023

January 26, 2024

When January 2023 began, we were still in "coming out of COVID" mode (though of course, it is still with us a year later). Many of us were just enjoying being able to resume "regular" activities, and reflecting on a Christmas where we were able to be with family and friends we hadn't been with for some time. We finally made masking optional in the Spring.

Our year began with a sermon series on Mental Health and the Church called "Healing Hurtful Thoughts", including a Messy Church event in January, "Beating the Blues".

Messy Church attendance in 2023 was a bit low, except for a very successful pre-Christmas event (featuring a guest magician) called "The Magic of Christmas". This coming year we will be trying quarterly events in partnership with the Church of the Advent. We continue to offer Faith@Home magazines to families with children and Learning Together is a well-loved part of worship time. This is a reminder that Learning Together is not an opportunity for folk to laugh at the "cute" things children say or do, but a chance for all of us to learn in ways that are accessible and fun. Children are the church of today, not tomorrow!

We had a well-attended "**United Church 101**" weekend in person and on Zoom – an introduction to the United Church and preparation for adult membership. We used resources from the wider church including the Rev. Dr. Janet Gear's video series, "The Theological Banquet". 8 people attended with several deciding to become full members of the congregation.

At our Annual Meeting, we discussed a "Mission and Ministry Reboot" with workshops and discussions held several times in the year to look at our current circumstances post-COVID and how the Spirit is leading us into the future. We met as a Council, and as a Congregation and surveyed stakeholders such as our renters and the Mayor and Fire Chief of Langford. This work continues as we identified 5 Core Values as a congregation: Faith, Inclusivity, Service, Wellbeing, and Stability. We will be working with these values to turn them from nouns into verbs – from values into actions and goals based on those values. Members of the Council met with representatives from the Pacific Mountain Regional Council to discuss how we can leverage our property and building to further our ministry. They emphasized that before anything else happens we need to have a very clear vision of our mission in the community and our goals moving forward.

I offered online evening worship during Lent, and a Lenten study on the book "Running from Empty". A few folks read "21 Things You Didn't Know About the Indian Act" as part of a "Reading for Reconciliation" effort. We had Easter worship on the beach and at the church.

**Pastoral Care** continues to be an area that requires lots of support as we have fewer people willing and able to visit homes and hospitals at the same time as we have more people needing those visits! If this is a ministry that calls to you, please speak to Rev. Heidi or Adele Morley about getting some training to help. I lead service at the Priory Hospital once every two months.

A big thank-you to members of the Affirm Team who have moved us forward on the path to certification as an **Affirming Congregation**. A highlight was participating in the Pride parade. We heard voices saying, "That is so cool that the churches are involved!"

Huge thanks to members of **Council**, **Property and Finance**, **and Ministry and Personnel** who have helped us navigate a year with lots of staff changes and challenges.

Members are needed for these teams as well. We're aware that serving on boards or teams is not popular these days; however, there are a minimum number of teams and committees needed to keep the church functioning. Without them, we will stumble. Thank you to all Team members.

Thanks to **all** the people who serve in so many ways, whether upfront or behind the scenes. The body of Christ needs all its members, to serve and live faith together.

The Council took the months of June, July, and August off from meetings, though the work of the church continued (including scrambling to find staff replacements after unexpected resignations!).

Through the summer months, the worship focus was on Discipleship and hearing the stories of Jesus' first followers. We also used a "Praise and Worship" contemporary format, which some loved, and others didn't (surprise!). With all the turnover in music staff, I decided to stick to the Revised Common Lectionary for services from late Fall through to the end of the Epiphany Season, as it made choosing music simpler. I am grateful to all the musicians with whom I have partnered in worship planning and leadership this year: Ryan Qu, Jeanne Campbell, Jill Ann Siemens, and Angela Carter. We have been blessed with amazing talent and musical ability! Thanks as well to the choir for your resilience!

In the Fall I reported to the Council with a sheaf of information gathered over the summer on ways to further clarify our mission.

With all the unpredictability we decided to keep Advent and Christmas simple and enjoyed a full house for worship on Christmas Eve. A thank you to our communion organizer Kathy Turcotte and head ushers Arden Noel and John Davies and their wonderful teams – especially the youngest of the bunch! It's such a blessing to have children, youth, and young adults present in the congregation and active in service.

We are delighted to welcome new congregants this year and hope you will feel very welcome and included in all aspects of the church's life and work. I am always open to getting together for coffee/tea/water and a visit - whether it's going for a walk, home, or meeting at a local coffee shop. Please, don't hesitate to ask; if you don't ask, I won't know if you'd like to get together!

**Continuing Education** for this year focused on three main areas: mission and planning; issues between white populations and BIPOC communities and how we can be a more just and inclusive society and church; and spiritual renewal (including a week of silent retreat).

Thank you to Avis Nichol for providing a stable, very competent, and cheerful presence in the office – and for getting all these reports out on time!

Blessings to one and all and may each step we take together bring us closer to God's longing for the Church of Jesus Christ.

Some highlights of the year were: celebrating Reverend Heidi's 25<sup>th</sup> Ordination Anniversary, The Mad Hatter Tea, our participation in the Victoria Pride Parade, the Westshore Community Band performance as well as our continued involvement in the Christmas Angel Gift and monthly community dinners.

We continue to expand our presence in the Western Communities engaging with the City of Langford and newly formed Residents Association and Outreach organizations.

This being said, as in the past, we are limited to what extent we can engage because of the limited members involved in the Council and other committees.

I am encouraged by those willing to organize fundraisers this year and the few who stepped up to get involved but we are still in desperate need for people to commit to a position on the Nomination List. Some have been in their positions past the 3 – 2-year terms and will be stepping down without someone shadowing them for that person to take over. Several core members are in multi-tasking positions; we cannot sustain this indefinitely. To expand Gordon United Church's involvement in our community or at the very least continue as we have, we need your help. Please consider getting involved.

In closing, I want to thank Reverend Heidi and those involved in the different committees for all your hard work this past year.

# Financial Reports

**Treasurer's Report to December 31, 2023** 

### A. Overview of 2023 Finances

With an especially great effort at the end of 2023, we were able to come up with enough income through donations and rent to be able to pay all expenses incurred in 2013. Consequently, we did not have to go into a deficit situation. Our savings were safe.

Let us start by comparing our finances at the end of 2023 to those at the end of 2022. Review the two balance sheets in this report - dated 2022 and 2023. Looking at our bank accounts it looks like a big loss. However, after several years of government support, we had to pay back the \$40,000 CEBA loan that we had borrowed from CRA. However, for paying back on time we were allowed to keep the other \$20,000 which we had previously received and reported in other years. The extra work required to take advantage of the COVID-19 years was worth it. Likely to the tune of \$71,456.70.

Designated Funds remain approximately the same. These are funds that we are holding for various groups or events.

### B. Details of 2023 Finances - Income

Overall, our income quite exceeded our projected income for all areas: collections, PAR, rentals, and special fundraising. The Property and Finance Team has had great success in renting space. With our economy being as it is and the shortage of rental space in our community, it has resulted in a successful rental rate and a way to give back to some of the special organizations.

We were blessed this year with some special donations and special fundraising. Some special donations have remained anonymous but are certainly appreciated. We can't forget Curtis Sage's involvement in the church and very much appreciated his bequeathing over \$13,666. Income from Cob's and Purdy's were like bonuses although a labour of love for several volunteers.

I didn't think I would be saying this, but it was exciting to see that expenses were lower than income over the year. Well done!

### C. Details of 2023 Finances - Expenses

Some expenses were higher than projected. However, a big increase in rental income over-compensated for this increase. That was good! Following are some of the notable expenses:

- 2 new photocopiers at \$1,964 to get rid of an expensive warranty
- Billing increase for the contracted custodian
- Increased cost of janitorial supplies
- Elevator maintenance
- New lawn mower
- Maintain parking lot overhead light
- New grass trimmer
- New recycle bins due to vandalism
- Updated road sign at entranceway
- Gardening supplies
- Draining Lake Gordon via septic
- Snow removal from Peak \$10,794.95 in 2023
- Insurance was higher than quoted but less than 2022.

Especially scary was the horrible cost of snow removal. It is expensive but a necessary evil to keep the parking lot and sidewalks safe to avoid injury to us or renters.

### D. Details of 2023 Finances – Mission and Service, etc.

These items do not get included in our finances as we are just passing along donations as they come in. However, donations to Mission and Service have been lower in the past 2 years which is likely a sign of the times.

### E. Projections for 2024

Now for the shock! The Council did its best to limit expenses for 2024. However, the projected deficit is estimated to be \$25,920.00 which compares to this year's projected deficit of \$17,057.46.

# **Community Dinners**

The Community Dinner at Gordon United Church is entering its 11th year of ministry to the Westshore Community. That is amazing when one considers how many meals have been provided over that period except for the COVID-19 pandemic period.

The Community Dinner is offered by a dedicated volunteer team who organize the menus, advertise, set up the CE Hall and as well make dishes and sweets. Community members also donate their service by making sweets, salads, and time toward this important ministry.

We offer a safe, clean environment for people to enjoy their meals and visits with friends and neighbours. Our kitchen is government-inspected once a year and there must be at least one person with a current Food Safe Certificate in attendance at each meal. Currently, there are at least two team members who have these certificates.

The meal is free and food donations are always appreciated. Monetary donations are always welcomed and will be added to the Budget Line Item of "Community Dinners" if you wish to contribute.

If you would like to help at the dinners or donate towards this important outreach Ministry, please do not hesitate to speak to myself, Ray Green, or Judy Muir if you have any questions.

Many thanks to all the volunteers who work so diligently to make these meals happen. Without you, the Community Dinners would be at risk and that would be a huge loss for the West Shore Community. The Community Dinners have been ongoing since their initial start in the summer of 2013. They, of course, took a hiatus whenever the Church was closed due to the Government Covid restrictions. Since January 2022, we restarted the dinners twice a month to reboot the attendance. We noted that when the dinners are suspended for any length of time, the attendance is slow to restart again. Dinners are not held during the summer and as of September, it was decided that the dinners would be held once a month due to the lack of volunteer involvement. Slowly, attendance has been increasing over the months to 40-50 patrons at each dinner either to eat in or take out. Not only are Gordon United Church members involved but we have volunteers from the Baha'i Faith, from the Westshore community (one very active supporter), and Starbucks Coffee who bring coffee/cream/sugar/cups to every dinner. We are grateful for this help and for the ability to provide these dinners for whatever reason a patron enters our CE Hall doors. It is with deep thanks to all who donate their time and contributions in support of this community dinner.

The Community Dinner is open to all.

The City of Langford accepted our application for Tax exemption and we have been approved exempt from 2024 to 2027.

The annual premium for our UCC Protect United Insurance Policy underwritten by HUB and initiated on December 1<sup>st</sup>, 2023, is \$8,630.00 (including taxes).

We would like to recognize the efforts of the Council, P&F Team, Gardening Crew and so many others who volunteer their time to help take care of Gordon United each year. It is truly appreciated.
